The persons signing for Client and the Disco(s) agree to be personally, jointly and severally liable for the terms of this contract.

All rebooking or subsequent engagement arising from the contracted booking are to be negotiated through this agency and not direct'.

The non refundable deposit of £80.00 minimum must be made in advance.

Cancellations must be made no later than 7 days prior to event start. Deposits will not be refunded.

60 minutes are required for assembly and 30 minutes for dismantle of the disco equipment.

Strobe lighting and special effects may be used at the disco(s) but this can induce fits, if strobes can not be used please tell the DJ before the disco starts (or make a note in the special requests).

The DJ/disco can not be held responsible for any health problems or physical damage to property or persons during the disco.
